

Future2 Make the Difference! Grants are designed for the benefit of socially and financially disadvantaged young Australians. Since 2007 Future2 has awarded grants of \$613,000 to community not for profits and charities working to give a better life to thousands of deserving young people.

Grant categories

The types of grants offered:

- One year grants of up to \$10,000
- Multi-year grants, with total value of up to \$30,000 over three years

Applications to receive grant funding are invited from organisations that have programs to address the needs of disadvantaged young Australians through:

- Education, including skills training and leadership development
- Engagement, including mentoring and juvenile justice programs
- Employment, including work experience and job readiness training
- Wellbeing, including remedial programs for drug and alcohol dependence
- Independent living and social inclusion.

Eligibility

- Charities with Deductible Gift Recipient (DGR) status
- Registered charities
- Not for profit organisations (NFPs)



Process and how to apply

1. NFPs / Charities: Identify and make contact with a FPA member who is willing to nominate your application for grant consideration

FPA member: Consider local NFPs / charities that you would like to nominate for a Future2 grant

2. FPA member to start the nomination section of the application form

FPA member emails the application form to the Not for Profit / Charity

3. Not-for-profit or charity completes the application form

The details provided in your application enable us to assess eligibility and to decide whether or not your funding request should be shortlisted. You should find it relatively quick and easy to complete. We do not at this stage ask you to provide financial details or evaluation methodology. The application may be completed online or entered into a Word template and submitted as a PDF attachment to email. The online application form may be saved for completion at a later date. The online link and the downloadable Word file can be found at www.future2foundation.org.au/grants

4. FPA member submits the application form to Future2

All applications must be received by 12 pm (midday) on Monday 1 August 2016.

5. Acknowledgement of receipt

Online applications will be acknowledged by an automated email confirming successful submission. Applications submitted as a PDF attachment to an email will be acknowledged by Future2 within 24 hours of receipt.

Please note:

If you are a Not for Profit or charity, and you do not have an existing contact or relationship with a FPA member, you can still apply for a grant! You can identify FPA members in your area in two ways:

- FPA website: Find A Planner, visit http://fpa.com.au/find-a-planner/ and enter your post code or
- Contact: info@future2foundation.org.au and ask to be put in touch with your local FPA Chapter.

Once you have identified your FPA member to nominate your grant application, the FPA member must:

- Be briefed about your organisation and the project for which funding is being sought
- Agree to complete a nomination form to support your application



Judging criteria

Future2 seeks to support projects and programs that give a second chance and hope for a better future to young Australians who are trapped in financial and social circumstances. Each application is assessed on its individual merit, with priority given to programs which:

- Focus on young people aged 12-25 years who may be
 - living in poverty
 - o homeless
 - o at risk of juvenile justice or transitioning out of it
 - o intellectually or physically disabled
 - socially isolated
 - living in dysfunctional family situations
 - fighting substance abuse.
- Address specific problem areas in ways that enable disadvantaged young Australians to move towards productive and fulfilling lives (see project categories above)
- Are designed to impact directly those most in need
- Try to identify and deal with the cause of a problem, not simply treat the after-effects
- Will continue to have an impact and remain sustainable well beyond the period of our support and, if appropriate, have the capacity to become self-sustaining
- Could be extended or replicated so that they benefit an increasing number of young people
- Are measured and evaluated to show the progress of the program, its outcomes and impacts
- Involve or have the potential to involve financial planning professionals in volunteering, fundraising, pro bono advice, committees, etc.
- May show evidence of collaboration with other agencies and organisations to implement or extend the reach of the project, or to share improved knowledge
- Are well-managed and prudently budgeted.

If your application is shortlisted (stage two), you will be invited to provide more information about your project and organisation. This may include copies of your latest annual report, financial statements, constitution, Deductible Gift Recipient certificate etc. Shortlisted applicants are also invited to submit video files of up to five minutes to support their written applications.



Please note:

In general, the following are not eligible for funding:

- Individuals
- Government entities, for example, government departments, statutory bodies and organisations wholly funded by government
- Religious groups, except for programs that support a non-religious purpose
- Programs outside Australia
- Capital funds and building works
- Recurrent costs or general operating expenses of an organisation
- 100% of the costs of any program unless future financial support can be demonstrated
- Study programs or conferences
- Research, except in special circumstances at the Board's discretion
- Travel, except where it is integral to the operation of a program
- Retrospective requests, general fundraising appeals or commercial sponsorships.

More information about Future2 and the Make the Difference! Grants process

Future2 is a charitable trust with Deductible Gift Recipient (DGR) status conferred by the Australian Tax Office. Future2 Foundation Ltd is a company limited by shares and guarantee that has the power to use the income and assets of the trust to the benefit of persons in 'necessitous circumstances'. The board has resolved to make grants to community not-for-profit organisations and charities that assist young Australians between 12 and 25 years of age who are in necessitous circumstances.

All grants are made at the sole discretion of Future2 Foundation. The shortlist is based on its evaluation of each application, judging criteria and the availability of funds. Future2 reserves the right not to award any specific grant for any reason, or for no apparent reason, no matter how deserving the proposed project may be or how closely the applicant has followed the guidelines and procedures. Rejection of an application does not mean that it is not well regarded. Future2 cannot enter into correspondence with individual grant applicants about the relative merit of the application or the specific reasons for deciding not to award a grant.
